# Minister's Foreword

**Heritage Ireland 2030** will establish a framework for the next decade along three Themes-

- National Leadership and Heritage
- Heritage Partnerships
- Communities and Heritage

A series of draft objectives under each Theme is detailed in this document. We now invite your views on these to help shape our heritage strategy. An Action Plan will be drawn up under each Theme. Full and open and regular review of objectives will be important and details of that are detailed in this document.

Heritage is for everybody. We need to strengthen partnerships with communities across the country to help strengthen our heritage and I look forward to welcoming you to a series of regional workshops during the consultation process.

**Heritage Ireland 2030** is the Government's commitment to a revitalised and refreshed National Heritage Plan.

**Heritage Ireland 2030** will recognise the vital role our heritage plays in our community, our economy and our society.

**Heritage Ireland 2030** will be a coherent, comprehensive and inspiring framework of values, principles and strategic priorities which will guide and inform the heritage sector over the next decade.

**Heritage Ireland 2030** will enshrine the shared responsibility of people,

communities, businesses and local and national Government in protecting our heritage and ensuring it is cared for into the future.

**Heritage Ireland 2030** will help us enjoy, understand and care for our heritage.

**Heritage Ireland 2030** will be formed around three Themes, built on a vision of our heritage being valued and protected for future generations, cherished and enjoyed:

- **National Leadership and Heritage**
- **Heritage Partnerships**
- **Communities and Heritage**

Each of these Themes will have specific actions and objectives, shaped by this public consultation.

# Heritage Ireland 2030 – Vision

*Ireland's heritage is valued, enjoyed and protected for future generations.*

Our heritage reflects our shared past, illuminates our understanding of the present and inspires and informs our decisions about the future.

Our landscapes are the foundation on which our society has been built. Diversity and richness in our heritage nurtures our sense of belonging, well-being, identity and place.

Access to heritage and opportunities to engage with it make an important contribution to our cultural, economic and social development.

Three Themes support the vision that sees Ireland's heritage valued, enjoyed and protected for future generations:

- National Leadership and Heritage
- Heritage Partnerships
- Communities and Heritage

## Heritage in context

**Heritage Ireland 2030** will build on heritage commitments in Project Ireland 2040 and inform other relevant initiatives at national and local level.

**Heritage Ireland 2030** will focus on our built and natural heritage. Other important aspects of our heritage are dealt with in other plans and strategies and lie outside the scope of this document. These include artistic and cultural traditions such as music, dance, games and language which are all essential and central parts of our heritage.

Most people's primary experience of our heritage is as part of daily life in their local communities. **Heritage Ireland 2030** will support local communities in caring for their heritage. It will underpin the increasingly important role that local authorities play in protecting and managing heritage for the enjoyment and benefit of all, providing a framework and context for local heritage plans.

Our management and protection of Ireland's heritage sits within a broad framework of national, cross-border, international and EU legislation and policy. It is affected and influenced by developments on the wider international stage.

# Theme 1: National Leadership and Heritage

Our heritage is central to our national identity and underpins our culture, economy and society.

At the national level, we must have an effective policy and regulatory framework for heritage that balances the needs of a modern society with a profound respect for the beauty and irreplaceability of our built heritage and habitats.

### **Objectives:**

1. An effective policy and regulatory framework and governance structure that supports an integrated approach to the protection, conservation and use of heritage.
2. Key heritage protection and management considerations integrated into the work of all Government Departments.
3. A coordinated framework for heritage policies and initiatives to maximise impact.
4. Better identification, conservation and restoration of heritage and measures to assess impacts on heritage, including climate change.
5. Better care of our built and natural heritage through increased investment from the economic return that it generates for society.
6. Investment in heritage training at all levels, creating jobs and providing business opportunities across the country.
7. Heritage investment at national and local level to deliver the best possible outcomes in terms of public good.
8. Improved use of technology to inform evidence-based decision making in heritage and to make heritage information accessible and available to all.
9. Strengthened and resourced regulation and enforcement.
10. Support and leadership for Ireland's continued participation in the World Heritage Convention and other relevant international frameworks.





## Theme 2: Heritage Partnerships

Our heritage belongs to every person who lives within and around it every day. At a national and local level we must work better together to protect, manage and promote it. This cannot be done without the help and support of partner organisations such as the Heritage Council, the local authority Heritage Officers, schools, community groups, businesses and experts who inform and advise on their various areas of expertise.

**Heritage Ireland 2030** will help form stronger and better heritage partnerships at all levels to ensure our heritage is valued, protected and enjoyed.

### Objectives

1. National and local government working effectively together to protect, manage and promote our heritage.
2. Effective partnerships between national government, local government, the private sector, NGOs and local communities.
3. Support for the Heritage Council's Strategy and its work in developing and improving educational outreach and community engagement.
4. Investment and innovation in heritage research, management and interpretation.
5. Strong education and apprenticeship programmes providing opportunities for retention and development of traditional heritage skills.
6. Improved partnerships and links between educational institutes, museums, business and others.
7. Improved quality of heritage information, guidance and advice as a resource for stakeholders, visitors, researchers and general public.
8. Strengthened co-ordination with the Office of Public Works, local authorities and private owners in the management and maintenance of our national heritage estate.

## Theme 3: Communities and Heritage

Local communities have a vital role to play in managing their heritage and should be able to learn about, care for, enjoy and share those things that are special about their places and their history.

**Heritage Ireland 2030** will listen to and respect the voices of communities and help and support them in taking care of their valued heritage.

### Objectives:

1. Improved levels of public engagement with heritage across the country.
2. Better supports for communities working to care for and promote their local heritage.
3. Improved access to natural and built heritage resources, public and private.
4. Access for all to archives, museums and heritage records.
5. Improved presentation and interpretation of heritage, including making better use of technologies.
6. Strengthened and well-resourced measures to protect local heritage.
7. Better opportunities and supports for people and organisations working in the heritage area.
8. Improved involvement of young people in understanding, caring for and celebrating their heritage.

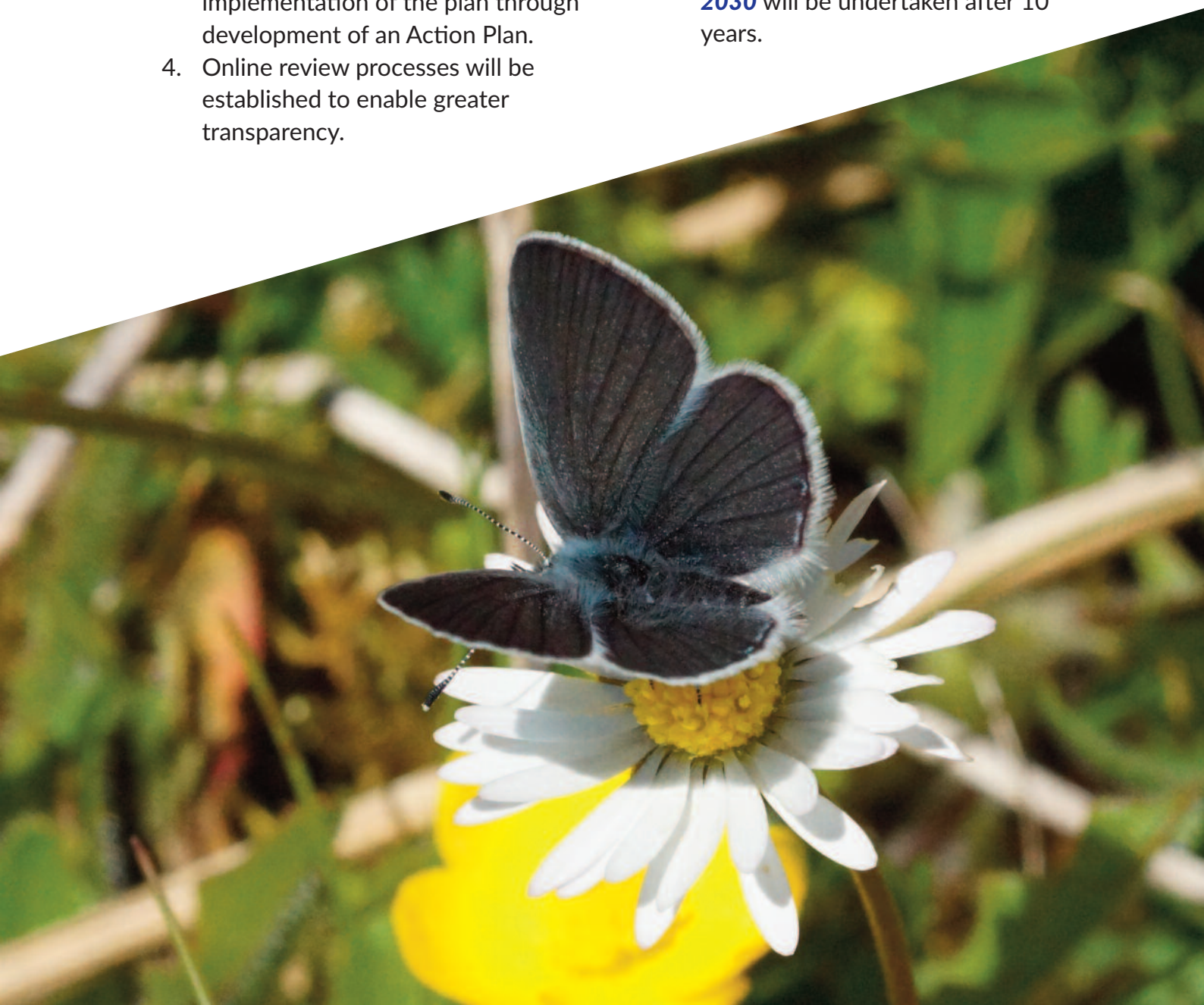


## How will the impact of Heritage Ireland 2030 be reviewed?

1. **Heritage Ireland 2030** will be reviewed every 3 years. A progress report will be produced after each review with clear recommendations.
2. Actions and objectives within the plan will be revised as progress is reviewed.
3. A steering group of stakeholders will oversee the roll out and implementation of the plan through development of an Action Plan.
4. Online review processes will be established to enable greater transparency.
5. A full review of **Heritage Ireland 2030** will be undertaken after 10 years.
