Dear Public Participation Network Member Group,

Following on from our Community Information Sessions held in March, please find enclosed a project brochure. This brochure was available at the Information Sessions and contains information regarding the proposed Ballivor Wind farm. Due to COVID -19 restrictions we were not in a position distribute this to you until now.

As the proposed development is at an early stage the number and location of turbines has not yet been determined. Subject to Covid 19 restrictions, we hope to hold another round of Community Information Sessions in local halls/community centres in the Autumn with more detailed information – such as the number and location of turbines - available.


