




### Vantage RE Community Benefit Funds

• **Sustainable Communities:** Projects that enhance the capacity of the population to achieve sustainability and self-sufficiency.

• Culture and Heritage: Projects that support history, heritage and culture.

SECAD

• **Financial details -** Submit a copy of a statement header from your organisation's account

• Your constitution - Submit a copy of your organisation's signed and dated constitution. If the group doesn't have a constitution, please contact SECAD

• Verify value of each item - You must submit quotations to verify the value of each item that you are seeking funding support

• If any individual item is less than €5,000, you need one quote for that item.

• If it costs €5,000 or more, you must provide three quotes from three different suppliers, or evidence that you tried to obtain three quotes.

# Tips for Completing your Application

# SECAD

#### Before you start

- Check and note the fund opening and closing dates
- Read the fund guidelines and keep a copy to hand when completing your application
- Confirm your group and project meet the eligibility criteria and are within the AOB

#### During the Application Process

- Gather your documents, constitution (signed & dated), copy bank statement (BIC, IBAN & group name visible) and quotations to support your project costs (costs in excess of €5,000 require three quotations)
- If your project includes construction/civil works, check with your local authority if there are any planning/exemption requirements
- If the property where the project will be completed is not owned by the group, ask for written permission from the property owner for the proposed project

#### **Before you submit**

- Take a look through your application, does it make sense? Are they any changes needed?
- Once you have answered every relevant question and uploaded all required information you are ready to hit submit

#### **Common Pitfalls**

- Applications where the project is not located within the Area of Benefit
- Applications where the project is poorly described
- Incomplete applications with information missing, quotes, bank statement, constitution, local authority permissions


# **Case Studies**

#### 👻 What was the idea

A steering committee was set up in January 2015 to plan and develop a fully equipped 400m, eight lane athletics track for the athletic community in Newcastle West. The project received huge support from schools both primary and secondary, the athletics clubs, the disability sector, community games areas and the general public.

A large area of County Limerick and part of North Cork and North Kerry will benefit from having the facility .

#### ి Planning for the future

The project which received full cross-party support from local politicians and Limerick City and County Council has gone through a process over the last 8 years. The physical development of the project which began in June 2021 is still in progress with drainage and foundation work nearly completed on the nine-acre site.

#### Engagement Services How has this funding made a difference?

The group were successful in their application for funding from the Wind Farm Community Funds, this along with additional sources of funding permitted the project to progress.

#### 👳 What was the idea

It had been a long journey for the group, who came together in 2003 to plan ahead with the option of refurbishing an old 1800`s schoolhouse in very bad repair or knock down the old building and replace it with a new modern style hall.

#### <br/> Challenges

Many obstacles had to be cleared including planning permission and financing. Financing a project of this size was a major concern for a small community. However, the committee forged ahead, and planning permission was granted by Wexford County Council in 2015 for the construction of a new hall and funding secured through the Raheenleagh Wind Farm community fund along with additional sources of funding.

#### **Second Community** Engagement Services How has this funding made a difference?

'The ESB who fund the Raheenleagh Wind Farm Community Fund showed a keen interest in the development of a new hall.'



#### 🝥 What was the idea

Cloughmills Community Action Team has been around for more than 20 years promoting community development and good relations in the rural village of Cloughmills and surrounding area of around 8000 people. A capacity building project was envisioned, designed to bring people of all ages together to learn new skills in crafts and creative arts with the intention that craft groups can be promoted to provide much needed recreational and social opportunities for a community coming out of the covid -19 pandemic restrictions. The crafts included willow weaving which is being grown as a local resource on site at the mill and creative arts such as felting, painting, pyrography as well as some wood working/ wood turning using the facilities at the local men's shed.

#### ් Planning for the future

The project was designed to build capacity within the volunteer group to engage in craft activity and learn new skills that can be passed on to others in the community. Everyone who took part gained a sense of achievement from learning how to complete a piece of willow craft. This group will provide the backbone of a willow weaving group that others can join, and it will add to the existing range of craft activities we can offer at the mill.

#### SectaD Community Engagement Services How has this funding made a difference?

'The group bonded well and were supportive of each other. The key lesson learned was how to prepare willow for weaving which was important as we grow willow on our site. The basic techniques for starting a piece of weaving were also very important and this will be enhanced through use of online tutorials as we go along.'

'The finished articles from the workshop were put on display at an open day at the mill in November under the caption ' Made at the Mill '. This was well attended by the community and new recruits were registered for the future. The group made willow trugs for use in the garden and also completed willow baskets for storing logs or vegetables from the garden'

# **Evaluation Criteria**



#### Viability and Sustainability of your project

Your project must aim to make a positive social and, or environmental impact.

If your project needs to purchase physical goods or materials, the project team must commit to sourcing the most environmentally and socially sustainable option available.

The project must show how it is linked to our Sustainable Development Goals.

The project should have the potential for longevity, and you should be able to show you can manage it in the long term. You should have thought about future funding or maintenance costs if relevant.

#### Your Capacity and Track Record

You must be able to show that you have a history of community involvement and experience delivering community projects. Otherwise, you must show that you have access to the relevant expertise and are registered with the Public Participation Network.

#### **Project value for money**

Your proposal should show value for money. Our funding should give you the support that you cannot get elsewhere through alternative funding.

SECAD will approach the fund design, implementation and evaluation to successfully complete the process of providing Grant Making Services to the satisfaction of all key stakeholders. Vantage RE have identified focus areas for the fund as follows:

#### Legacy projects


Targeting legacy projects that will have the greatest impact on the most important social and environmental challenges facing communities

#### **STEAM projects**

Projects that develop access to educational opportunities in Science, Tech, Engineering, Art and Maths.

#### Tackling climate change

Projects that are helping to tackle climate change and encouraging sustainability



#### Sustainable Communities

Supporting the community: Projects should contribute to the success and sustainability of the community. Building the capacity of voluntary organisations to learn skills to become sustainable organisations

#### Leverage value

Through analysis of local, national and European funding sources - explore possible areas where the Community Benefit Fund could act as the 'matching finance or leverage' for these investments

#### **Biodiversity**

Projects that and enhance the biodiversity of the local area and communities' access to the natural world.

NOTE: through our engagement with META we identified potential areas of overlap and where we can collaborate with a key focus on leveraging community engagement (participating in events like open days as opportunities to promote renewables/Vantage such as visits to solar farm, STEAM projects etc). Through this collaboration we can ensure that the benefit is dispersed across a wide range of projects (linked to key funding principles as above) and compliments the existing META community benefit framework. META funds open annually in September with grant recipients announced in spring.
