Introduction

The Maritime Area Stakeholder Forum (the Forum) will be established by the Maritime Area Regulatory Authority (MARA) to facilitate structured and ongoing engagement with key stakeholders involved in or affected by regulatory activities in Ireland's maritime area. The Forum will provide a platform for dialogue, collaboration and the exchange of information to support MARA's regulatory and strategic functions.

Purpose

The purpose of the Forum is to facilitate structured engagement between MARA and stakeholders in Ireland's maritime area.

The Forum will consist of representatives from maritime user groups. The aim is to build trust, share information and enhance decision-making through inclusive dialogue with a view to promoting transparency.

The Forum is intended as a structured platform to:

- Provide updates on MARA's role and developments
- Share knowledge on best practices in the maritime regulatory landscape
- Inform MARA's application requirements and processes and share lessons learned by all
- Inform stakeholders of legislative or policy updates affecting MARA
- Inform MARA of developments in the various sectoral areas
- Any other relevant topic of relevance to MARA's functions.

It will provide an opportunity for stakeholders to flag upcoming developments and to share their experiences of interactions with MARA in a constructive fashion.

The Forum will be non-statutory, non-binding, and not a decision making body. It is expected to meet 2-3 times a year.

MARA will chair the Forum and also provide the secretariat.
