## EUROPEAN SEMESTER

EAPN was part of a group of civil society organisations that met with the European Commission on January 12th as part of the European Semester process. This is an annual process where the EU monitors and evaluates every member state's fiscal, economic, social, employment, environmental, energy and climate policies, reforms and investments. We very much welcome the Commission's engagement with civil society and that last year they issued a recommendation in relation to the need for the government to increase the supply of social and affordable housing and strengthen the labour market and social inclusion of disadvantaged groups, in particular persons with disabilities and single parents. The issues of poverty, social inclusion, the need for a more progressive broadening of the tax base, and development of public services including in housing provision were all discussed. Recommendations from the process will be released in July.



## PEOPLE EXPERIENCING POVERTY -BRUSSELS MEETING

On December 11th/12th the annual meeting of people experiencing poverty, organised by EAPN Europe, took place in Brussels. Although we were unable to attend in person, EAPN fully supports this initiative. Challenging the stigma associated with poverty, reinforcing the fact that poverty is a societal rather than an individual failing, and strengthening solidarity and collective action is the most effective way forward, as the EU prepares to bring forward its first Anti-Poverty Strategy.

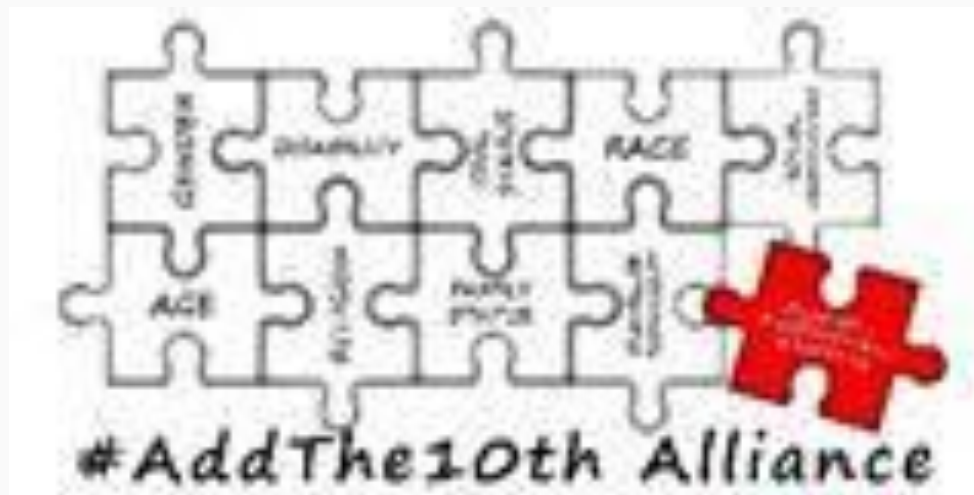


## EU RECOMMENDATION ON MINIMUM INCOME REPORT 2025

We were assisted in with colleagues from the Irish National Organisation for the Unemployed (INOU) and the Disability Federation of Ireland (DFI). The interim report on the state of play was published by the European Commission and the Social Protection Committee late last year.

## GOVERNMENT DELAYS EQUALITY LEGISLATION

EAPN is very appreciative of the efforts of the UN Special Rapporteur on Extreme Poverty & Human Rights, Olivier De Schutter, to contact the Irish Government before Christmas and press for the enactment of the Equality (Miscellaneous Provisions) Bill 2024, providing for socio-economic disadvantage to be a ground for discrimination in law. We were therefore very disappointed that the Government has ignored this call in the Spring Legislative Programme. Every delay means suffering for many people. This legislation has been discussed for over ten years. All of the studies and research have been conducted. There is no excuse for this delay. We urge everyone to step up the pressure.
